The NRC in its 250th Meeting (Part-IX), on the basis of the scrutiny of the documents submitted by the institution input received from the Visiting Team Report and video-graphy observed that the following institutions have adequate financial resources, accommodation, library, laboratory, land and building as prescribed in the norms and standards for the course applied and that it fulfils such other conditions relating to infrastructural and instructional facilities as required for proper functioning of the institution for a teacher education programme and decided to issue Letter of Intent (LOI) under clause 7(13) of the NCTE Regulations, 2014. 2. As per provision of clause 7(13) of the NCTE Regulations, 2014, the process of appointment of qualified staff as per policy of State Government or University Grant Commission or University or Affiliating body may be initiated by the institution. The affiliating body will provide all assistance to the institution to ensure that the staff or faculty is appointed as per National Council for Teacher Education norms within two months. The institution shall submit the list of faculty, approved by the affiliating body, to the Northern Regional Committee, Jaipur.

3. In this regard as per decision taken by NRC in its 199th meeting, it is clarified that the above implies that where there exists a provision of nomination of expert/experts for the Selection Committee by the affiliating body, the same is to be adhered to. In the absence of such a provision in the Act/Statutes of the affiliating body, the institution shall select faculty members by employing a transparent, objective and judicious process and shall get the list of selected faculty approved by the affiliating body. This approved list, along with details of educational qualifications and teaching experience, shall be submitted by the institution to the Regional Committee.

4. As per Regulations, 2014 an institution can be given Maximum Two units for D.El.Ed. & B.Ed. programme.

5. In view of above, before grant of formal recognition under Regulation 7(16) of the NCTE Regulations, 2014 considered, the following documents are required to be submitted by the institution:-

- a. The copy of letter issued by the affiliating body to approve the faculty.
- b. Advertisement given for inviting application for appointment of faculty and staff.
- c. An affidavit on Rs. 100/-stamp paper to the effect that the institution has selected staff as per NCTE/State/University/Affiliating body norms.(format Enclosed).
- d. Copies of educational & professional qualification certificates of all teaching staff showing their eligibility for appointment as per the NCTE norms and experience certificate of the Principal/IOE.
- e. Downloaded copies of the website of the institution with the hyperlink of the same as per provisions of Regulation 7(14) of the NCTE Regulations, 2014.
- f. The institution shall create FDRs of Rupees Seven Lakhs and Rupees Five lakhs in respect of Endowment Fund & Reserve Fund as per clause 10 of NCTE Regulation 2014. The FDRs should be in the name of the institution/society and Regional Director, NRC, Jaipur. The copies & FDRs alongwith Form "A" showing details of the FDR Account No., Name of the Bank and address, Phone No. of the Bank, Branch Code, Code, Signature ID Code of the Issuing authority of the FDR shall be submitted by the institution (Form Enclosed copy). As per provisions of the NCTE Regulations, 2014 followed administrative guidelines issued by NCTE Hqrs., the FDRs of Rs. 7 lakhs and Rs. 5 lakhs are required for programme and not per unit.

6. This letter of intent is subject to the following conditions:-

- (i) The institution shall ensure that the institution is composite institution as per the definition of composite institution given in the NCTE Regulation, 2014. If at any stage, if it is found that the institution is not a composite institution, the recognition, if granted will be treated as withdrawn and the sole responsibility of the same will be of the institution. However, in the case of existing institutions permitted for admission intake, shall have to ensure that they are to become composite gradually preferably the academic year 2016-17.
- (ii) The NOC of the affiliating body submitted by the institution, if found fake at any stage, the recognition, if granted, will be treated as withdrawn and the sole responsibility of the same will be of the institution.

7. You are advised to comply the above requirements as early as possible so that the matter could be considered for formal recognition under clause 7(16) of the NCTE Regulations, 2014.

8. Admissions shall not be made until formal recognition under clause 7(16) of the NCTE Regulations, 2014 is granted by the Northern Regional Committee. NCTE and affiliation is obtained from the University/examining body concerned.

9. The compliance report/reply alongwith all necessary documents accompanied with an Affidavit in support of the reply on the above points should be submitted **within two months of issue of this letter, failing which approval will be taken as deemed fit and proper.**

10. The Regional Director is an authorized officer from the side of Northern Regional Committee. NCTE and concerned Bank officers are requested consider and treat this letter as authorization required for operating of conversion of FDRs in joint operation in the name of Management of the institution & Regional Director, NRC, Jaipur.

4. The institutions shall adhere to the fulfillment of the provisions of the NCTE Regulations, 2014 and ensure the following before commencement of the session:-

- The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- The institution shall comply with the condition as laid down in the clause 8(3) of the NCTE Regulations, 2014 which provided that "An institution which has been recognized by the Council shall obtain accreditation from an accrediting agency approved by Council within five year of such recognition."
- The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- As per the provisions of the NCTE Regulations, 2014 the following norms have been prescribed for staff/ qualifications/administrative and professional staff/terms and conditions of service etc.

5. Staff

5.1 Academic Faculty

For an intake of up two basic units of 50 students each, the Faculty strength shall be 16. The Principal or HOD is included in the faculty. The distribution of faculty across subject areas may be as under:

Note: (i) If the students' strength for two years is one hundred only, the number of faculty shall be reduced to 8. The faculty in specialised areas and some of the pedagogic courses can be shared with the other teacher education programmes.

(ii) Faculty can be utilized for teaching in a flexible manner so as to optimize academic expertise available.

5.2 Qualifications

A. Principal / HOD

- (i) Postgraduate degree in Sciences / Social Sciences / Arts/ Humanities with minimum 55% marks, and M.Ed./ M.A (Education) /M.El., Ed with minimum 50% marks.
- (ii) Five years teaching experience in a Teacher Education Institution.

Desirable : Degree/ Diploma in Educational Administration / Educational Leadership.

B. Perspectives in Education/ Foundation of Education; & Curriculum and Pedagogy

Teacher Education in D.El.Ed. should have Masters Degree in Social Science/ Humanities/ Science/ Maths/ Language with 50% marks, and M.Ed with 50% Marks or M.A (Education) with 50% marks [except (two) positions where the requirement shall be Postgraduate in Philosophy/Sociology/Psychology with 50% marks and B.El.Ed. or B.Ed. or D.El.Ed. with 50% marks, or M.Phil/ Ph. D in Education]

C. Physical Education

- (i) Masters degree in Physical Education (M.P.Ed.) with minimum 50% marks.

D. Visual and Performing Arts

- (i) Masters degree in Fine Arts/ Music/ Dance/ Theatre with 50% marks.

5.4 Terms and Conditions of Service


The terms and conditions of service of teaching and non-teaching staff including selection procedure, pay scales, age of superannuation and other benefits shall be as per the policy of the State Government/Affiliating body.

4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable and compliance of the following by the affiliating body, State Govt and also the concerned recognised Institution:-

- (i) The affiliating bodies/State Govt. shall be required to verify the authenticity of the land & building documents with the required land & built up area as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- (ii) The affiliating body shall ensure that the institution is composite institution as per the definition of composite institution given in the NCTE Regulation, 2014. If at any stage, it is found that the institution as not a composite institution, the recognition, granted will be treated as withdrawn and the sole responsibility of the same will be of the institution. However, in the existing institutions permitted for additional intake, shall have to ensure that they are to become composite gradually preferably the academic session 2016-17.
- (iii) The NOC of the affiliating body and staff approval thereof submitted by the institution, if found fake at any stage, the recognition, granted will be treated as withdrawn and the sole responsibility of the same will be of the institution.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - (i) Copy of the Application Form
 - (ii) Land and Building Particulars
 - (iii) Staff Profile
 - (iv) Recognition letter
 - (v) Information for having fulfilled the norms & standard and other required conditions.
7. In case if the land is in the name of the Society/trust, the land is to be transferred within six months in the name of the institution, failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.
8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
9. Further, if the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE's website.


